<u>Vettes owned</u>: I have a black '84 Cross-Fire coupe that I acquired in the fall of '98 from a co-worker. July 27 – HPDE on the Main Track at Summit Point

NVCC is hosting a high speed driving school on July 27th on the Main Circuit at Summit Point. Registration will be open to 25 per group (novice, intermediate, and advanced), for a total of 75 slots. Since this is a high speed event, rules require a MOUNTED fire extinguisher and roll bars in convertibles, long pants and long sleeved shirt, a Snell SA 2000 (or newer) helmet and closed toe shoes. New Driving Fines for Virginia Residents

At the June general business meeting, Tom Shea brought some information on a new Virginia law that assesses civil fines for traffic violations. I thought it important for all to know, so I've included some pertinent info in this newsletter.

During its 2007 Session, the General Assembly of Virginia passed House Bill 3202 (Chapter 896), which was designed to provide additional funds to address various transportation needs in the Commonwealth. (See this link for the bill: http://leg1.state.va.us/cgi-bin/legp504.exe?ses=071&typ=bil&val=hb3202.)

Some key elements:

- Offense must have taken place on or after July 1, 2007.
- These are classified as "civil remedial fees" to be assessed against **Virginia residents only** (i.e., those who have a drivers license from VA).
- These civil remedial fees will not apply to traffic infractions like failure to obey a highway sign or failure to yield or parking too near a hydrant. They apply only to certain motor vehicle-related or driving felonies and misdemeanors.
- The fees cannot be suspended or reduced. By law, an applicable civil remedial fee must be assessed by the court in full.
- These fees are in addition to any other fees, costs, or penalties imposed pursuant to the Code of Virginia.
- The civil remedial fees are imposed in three equal parts: one part due at the time of conviction, with the 2nd part due within 14 months and the 3rd part due within 26 months. The DMV will be responsible for billing the 2nd and 3rd portions.
- Prepayable offenses: Any offense for which a driver can "prepay" (i.e., admit guilt by sending in a payment of the fines rather than going to court) must now include the additional fees (1st payment portion in addition to applicable fine/court processing fee), or the payment will not be accepted.

The purpose of these fees? The statute states the purpose of these fees is "to generate revenue from drivers whose proven dangerous driving behavior places significant financial burdens upon the <u>Commonwealth</u>." However, an article on WJLA channel 7's website states that State Delegate David Albo, R-Fairfax County, devised the idea to make the worst drivers pay for the cost of new roads. "We could charge everybody an extra \$100 a year or we could charge abusive drivers ... People with good driving records don't have to pay."

The fees are civil fines, not traffic fines, because revenues from traffic fines are restricted to educationrelated expenses and are not available to fund new transportation projects. And since civil fines lack the enforcement authority of traffic fines, Virginia must tie them to personal transactions with the state, such as registering a vehicle or renewing a drivers license (hence the DMV's involvement).

The new fee schedule is as follows:

- (a) Driving on a suspended license: **\$750 total** (each payment is \$250).
- (b) *Reckless driving*: **\$1,050 total** (each payment is \$350).
- (c) DUI and related offenses: **\$2,250 total** (each payment is \$750).
- (d) Other misdemeanors: **\$900 total** (each payment is \$300).
- (e) *Felony convictions*: **\$3,000 total** (each payment is \$1,000).

Here are some notable violations to pay attention to for those of us that aren't the best at being defensive drivers ... or perhaps these are just the ones that worry me the most ...

MISDEMEANOR – **\$900** total:

OPERATE MOTOR VEHICLE WITH BELOW-STANDARD TIRES (Hmmm ... would racing slicks count?) OBSCENE VIDEO IMAGE VISIBLE OUTSIDE VEHICLE (Ok, not quite sure what this is, but it sounds funny ... or at least like fun ... so I had to include it!)

RECKLESS DRIVING (RD) – **\$1,050** total:

RD - DRIVE TOO FAST FOR CONDITIONS (MISDEMEANOR) RD - SPEEDING EXCESS OF 80 MPH (MISDEMEANOR) RD - SPEED 20/MORE ABOVE SPEED LIMIT (MISDEMEANOR) RD - RACING (MISDEMEANOR) AGGRESSIVE DRIVING

Each of the Reckless Driving offenses above has a complementary Felony offense, which carries a **\$3,000** (total) fine.


But wait, there's more ...

Those with 8 or more points on their license will be subject to additional fees as well: for every year someone has 8 points on their license, a \$100 fee will be assessed, with an additional \$75 for each additional point. Since points for speeding stay on a license for 5 years, these fees can get expensive. Also, according to the WJLA website, additional fees, fines and taxes are expected within the year for northern Virginia to finance new road projects.

Other new laws include:

- Those under 18 will be ticketed for talking on a cell phone while driving.
- Smoking within 20 feet of a gasoline pump is a misdemeanor, with a fine up to \$500.
- Localities have the option to start using "photo red" cameras at intersections to catch red light runners. To do this, officials run the license plates of cars photographed running the light and send a citation to the registered owner. IMPORTANT NOTE: If someone else was behind the wheel, the owner can sign an affidavit saying so and avoid the civil penalty.

Time to keep the racing and speeding confined to the race track!! While I'll miss everyone up here in Virginia, at least this is one thing to make me feel better about moving to North Carolina ... the speed limit is 70 mph on some of the highways around Raleigh!

Change in the GM Nav Disc Update Program No more two free nav disc updates for 2008 models...

Sales and Service Bulletin

Models: All 2008 models with factory-installed, in-vehicle navigation -- either standard or optional (Cadillac CTS, SRX, STS, XLR, Escalade, Escalade EXT, Escalade ESV – Hummer H2 and H3 – Buick Lucerne and Enclave – Pontiac Grand Prix and Torrent – Saturn Outlook and Relay – GMC Sierra, Yukon, Yukon XL, Envoy, and Acadia – Chevy Silverado, Avalanche, Tahoe, Suburban, Trailblazer, Equinox, Uplander, and Corvette)

The purpose of this bulletin is to inform GM dealers and dealership personnel of a change to the GM Nav Disc Update Program. The program previously included two free DVD map updates for customers who purchased a GM vehicle with a factory navigation system, installed when the vehicle was built.

The program has been modified for the 2008 model year and beyond. Free DVD map updates are no longer included. This does not affect the original DVD map disc which is provided with the new vehicle. This also does not affect the owners of 2006 and 2007 model year vehicles with factory in-vehicle navigation. Those owners are still eligible to obtain a free update or updates.

DVD map updates will continue to be offered by the GM Nav Disc Center. The data on the DVD map disc ages at a rate of 15-20% per year. As the data ages, the functionality of the navigation system declines. The DVD map updates are available annually at the beginning of the new model year. The updates are currently priced at \$199 + shipping.

The GM Nav Disc Center can be contacted for both disc orders or for assistance with nav system operation. Order discs via the website, www.gmnavdisc.com, or by phone, 1-877-NAV-DISC (1-877-628-3472). Contact information for the Center is also included in the Navigation Owner's Manual Supplement (in the glovebox) and on the face of the DVD disc included with the new vehicle.

Any feedback on this program change should be provided to your Field Sales or Service contacts.

How does the NCM compare to other Museums across the country?

The American Association of Museums (AAM) recently conducted a survey of museums across the nation. 809 museums responded, including the NCM, and the results were compiled in a book produced by the AAM. The following summarizes some of this information and includes comparative information for the NCM.

Earned Income per Museum Visitor (Total earned income divided by annual attendance of 125,000)

AAM – Large Institutions earned \$10.65 per museum visitor NCM – Earns \$56.84 per museum visitor

Store (81.5% of the responding organizations have a gift shop or store)

AAM – Gross revenue per visitor \$1.55

NCM - Gross revenue per visitor \$25.33

AAM – Gross profit as a percentage of operating income 6.5%

NCM – Gross profit as a percentage of operating income 29%

The following are more comparisons from the AAM of the NCM to other museums across the country. Large Institutions are classified as museums with a budget of \$3mil. The NCM falls into this category.

The NCM does not receive significant government funding, contributions or endowments.

Staff

- AAM The median number of staff for the larger institutions is 71 full-time, 32 part-time staff and 250 daily volunteers.
- NCM Has 27 full time and 46 part time staff, which is less than half the staff of the average large organization. The NCM do not utilize volunteers for daily operations, but have several who provide assistance during events, at show, club visits and in their own towns.

Admission Fees

- AAM 61% charge admission fees. The average standard, non-member adult fee is \$6.00
- AAM Large institutions average standard, non-member adult fee is \$9.00

NCM - Standard, non-member adult fee is \$8.00

Marketing Expenses (Materials and activities that promote attendance or the purchase of museum membership or products, including design, printing and mailing costs for brochures and direct-mail promotions, plus advertising)

AAM – 4.4% of total operating expenses or median of \$60,000.

AAM – Large institutions 5% of total operating expenses or median of \$430,397.

NCM - 6% of total operating expenses or \$258,177
