### The Origin of the Wave

Ever since Corvette No. 00001 first met Corvette No. 00002 on the road, their drivers saluted each other with waves. Today, unfortunately, this grand and glorious tradition is wavering. WAVE WHEN YOU PASS ANOTHER CORVETTE!

There's one item of standard equipment that comes as a pleasant surprise to every new Corvette owner. It's an instant wave of recognition he or she receives when he meets one

of their ilks on the road. The first time it happens, they will be taken by surprise. He immediately thinks: 1. He has been mistaken for Sterling Moss. 2. His lights are on. 3. He has just been given the bird.

Soon, however, the new Vette owner anticipates, indeed even relishes, encountering other Vettes as he drives. During this period, he experiments with his waves, running the gamut from the gaping "yoo hoo" to the ultra cool "two finger flip." He perfects his timing, making sure he affects neither a too-early wave, nor the jaded "oh brother" too-late variety. Determined not to be one upped, he even develops a defense mechanism for non wavers, usually settling on the "Wave"? My hand was just on the way to scratch my head" approach. (This is especially useful when you're not driving your Vette, but you forget, and like a dummy, you wave anyway.)

Indeed, one of the most perplexing problems facing a would-be waver is what to do when driving next to a fellow Vette owner. Passing him going in opposite directions is one thing. Greetings are exchanged, and that's that. But what happens when you pull up next to a guy at a light, wave, nod, smile and then pull up to him at the next light, a block later? Wave again? Nod bashfully? Grin self-consciously? Ignore him? Or take the chicken's way out and turn down the next side street? If you're expecting an answer, you won't find it here. Sad to say, some questions don't have any. SAVE THE WAVE!

Girl-type Corvette drivers also have a unique problem: to wave or not to wave. This miss or misses who borrows her man's Corvette for the first time is immediately faced with this quandary. Should she wave first and look overly friendly, or ignore the wave and look like a snob? Most ladies who drive their own Vettes prefer to suffer the latter rather than take a chance of being misread. For this reason, all girls are excused for occasionally failing to return a well-meaning wave. So are new owners who are still learning the ropes.

There is no excuse, however, for a guy who refuses to return the wave, not out of ignorance, but of arrogance or apathy. While this type of behavior is the exception to the rule, it seems a few owners of newer models refuse to recognize anything older than theirs, while some others simply won't wave, period. Boo on them. These ding-a-lings don't seem to realize that they are helping to squash a tradition that had its beginnings back when most of us were still driving tootsietoys.

## **GM says Corvette will stay in BG**

Michigan television station reported rumor that production may move.

General Motors. officials say the Corvette will continue to be made in Bowling Green despite wild speculation among the auto world that production could move. Officials refute rumors that Corvette production will move to Lansing, Mich., an idea that was sparked by a \$190 million project GM recently announced that would bring about 600 jobs to the Lansing plant. About 470 workers are employed at the General Motors Bowling Green Assembly Plant.

"There are no plans to have any significant changes as to how Corvettes are manufactured and where," said David Caldwell, communications manager for Chevrolet.



"There's really nothing going on here ... this chitter-chatter in Lansing has no direct application to Kentucky."

A Lansing television news station picked up on the idea and fueled rumors that the Corvette might move, he said. The station interviewed an economist, who speculated that the project could fund Corvette production, and the president of the local United Auto Workers in Lansing, who said the plant is ready for any type of production, including the Corvette.

"That's normal talk because you want to let the company know you can build whatever car you can," said Eldon Renaud, president of the local UAW in Bowling Green. "I don't think there's anything to it." Now, a few online news articles and several blogs have published speculation that Corvette production might move from Bowling Green.

Some argue that the Corvette is rear-wheel drive and, therefore, is a perfect match for the Michigan plant. Others argue that the Bowling Green plant assembles only one car and is dead weight for GM. But GM disputes those claims. "This is a very unique group of people and facility in the sense that they are very valuable to the specialty manufacturing that a great sports car like the Corvette requires," Caldwell said about the Bowling Green plant. "It's a specific and unique and highly skilled operation there that obviously has proven to do a very good job for a long time."

The Corvette has been manufactured in Bowling Green for the past 29 years and has been one of the city's major employers. It has also become a part of Bowling Green's identity - many people associate the city with the Corvette.

Gov. Steve Beshear recently signed legislation into law at the Bowling Green plant, making the Corvette the state's official sports car. GM also recently launched a commercial for the Corvette, parts of which were filmed in Bowling Green, said Andrea Hales, communications manager for the Bowling Green plant. And Chevrolet has launched a new program dubbed the Corvette Engine Build Experience, which allows customers who purchase a 2011 Corvette Z06 or ZR1 to travel to Wixom, Mich., and help make their cars' engines. They then can watch their vehicle be assembled at the Bowling Green plant and have it delivered at the National Corvette Museum in Bowling Green.

This weekend, hundreds of Corvette enthusiasts from across the country will travel to Bowling Green to take part in the annual National Corvette Homecoming. Still, several local workers have expressed concerns about the rumors, but "they understand it's pure speculation," Hales said. And, for many workers, such rumors are not uncommon.

"We've heard speculation since we got here. There was speculation in St. Louis long before it came to Bowling Green," Renaud said. "We've been here since 1981, and I think we've met every benchmark we were asked to and I'm confident we'll just continue building good cars and keep it here."

### **Corvette Racing Takes Third in Eventful Utah Grand Prix**

Magnussen and O'Connell battle back to podium finish after Pit Lane penalty

SALT LAKE CITY - Sometimes the box score doesn't tell the whole story of a race. Corvette Racing's third-place finish in the American Le Mans Series Larry H. Miller Dealerships Utah Grand Prix was the result of a determined effort in the heat of the Utah high desert. Johnny O'Connell and Jan Magnussen overcame intense competition on the track and a penalty in the pit lane to take their No. 3 Compuware Corvette C6.R to a hard-earned podium finish at Miller Motorsports Park.

The No. 3 Corvette C6.R finished one lap behind the No. 62 Risi Competizione Ferrari 430 GT and the runner-up No. 92 Rahal Letterman BMW M3 GT. The No. 4 Corvette C6.R of Oliver Gavin and Olivier Beretta encountered an electrical problem on



the second lap, finishing 10th after losing three laps to the leaders during repairs.

"We're not winning, and that's what we're here for, but we will," said Magnussen. "When we can have good results on our bad days, then I'm sure it will be fantastic on our good days."

O'Connell started seventh in the GT class, lost a spot in the opening laps, and then methodically began to overtake his rivals. He was fifth at 30 minutes into the 2-hour, 45-minute race, and third at the 50-minute mark. Magnussen then took over just as the first hour was completed, and set off in pursuit of the leaders.

"The idea is to push hard and stay out of trouble," said O'Connell. "At the start a GT car went inside of me, but we got that position back and then started picking guys off. The car was good under braking, and as the fuel load went down we were getting quicker. When (crew chief) Dan Binks is telling me that guys are coming back to me, that's like blood in the water for a shark."

As the air temperature climbed to 90 degrees and the track sizzled at 112 degrees, Magnussen put the heat on the second-place BMW of Bill Auberlen. The Dane pitted for fuel and tires with 36 minutes to go, but a brush with the air jack hose incurred a stop-and-go penalty. Magnussen emerged in fifth, and moved up to fourth when the No. 45 Porsche pitted. With nine minutes left on the clock, he passed the No. 92 BMW of Dirk Mueller for third coming out of Turn 6.

"It was a good, fair fight with both BMWs," Magnussen said. "I managed to get by for third after he made a small mistake. I faked a move going in and he reacted to it. It was unfortunate that we had that penalty in the pits. It was one of those small things - sometimes the luck goes your way and sometimes the luck goes against you. I think our year has been the latter so far."

Crew chief Binks explained: "When I unplugged the air jack wand, it bounced against the wall and went under the tire. At the time you get upset, but the officials made the right call. We got a penalty, and Jan raced his heart out to third."

The No. 4 Corvette's race unraveled on the second lap when it slowed in Turn 5 with no fuel pressure. Beretta's attempts to restart the car were futile, and it was towed into the pit lane. The Corvette crew quickly repaired an electrical connection and Beretta rejoined the fray.

"I made a good start, and suddenly the engine cut out," Beretta said. "I knew I could not restart the car by myself on the track. These are the kind of things you want to forget and think about the next race. We have had so much bad luck, I hope it will end soon."

The No. 4 Corvette pitted at 1:06 for fuel, tires, and a driver change as Oliver Gavin replaced Beretta. Gavin then ran to the finish on one set of Michelin tires, turning laps as fast as the leaders, but the deficit was too great to make up.

"The team showed great character today," said Corvette Racing program manager Doug Fehan. "You can't work any harder for a third-place finish than we did today. Hats off to Johnny, Jan and the crew for never giving up - their effort paid off with a podium finish, and that's important in the points race."
