# HISTORIAN'S STING RAY VS. STINGRAY by Jeff Kirk

Hi everyone! One of the most beautiful Corvettes, in my humble opinion, is the Sting Ray. Created during the beautiful C2 and C3 body styled years, most people consider any C3 Corvette a Sting Ray. However, not all C2 or C3 Corvettes are Sting Rays, and no Sting Rays are Stingrays.

Membership is strong and we should end the year with close

to 10 grand in the bank if our budget projections are correct.

What a great year this was for NVCC!

We had out 1st Concour in three years and it was the best we have ever had. Many thanks go out to Collin MacDonald and staff for pulling this one off and making us a couple grand to boot.

Spooktacular was a great success as usual despite rain throughout the whole weekend. George Skalkeas did an outstanding job and even got in a few runs with his gorgeous Corvette.

Autocross' and rallies went off without a hitch thanks to the leadership of Mike Sarver and Dick Hammaker respectively.

Barb Shaw, Barbara Foor, Judy Patrick, Mark Bergstrom, Andrej Balanc, Don Patrick, Tom Green, and Jeff Kirk all did an outstanding job keeping the club informed and the club records straight in their respective duties.

All I can say is "WOW", what a crew. All of you made my job easy and made me look good. I couldn't have done it without you and for that you have my infinite thanks.

There are actually two different models, the Sting Ray and the Stingray. From 1963 to 1967, Corvette had the Sting Ray, and from 1969 till 1976, the Stingray. Note the lack of a Sting Ray in 1968. The C2 was in existence from 1963 to 1967, and the C3 from 1968 to 1982.

In 1963, Corvette had weathered the trials of being a new car, and had actually advanced to become the premier American sports car, led by both it's high performance power plant and the withering of the 2 seated Ford Thunderbird into obscurity. There was also the introduction of the Corvette Coupe in 1963 (Looks like a future Trivia question doesn't it?), in addition to it's standard convertible model. However, Corvette's Engineers, led by Zora Arkus-Duntov, weren't happy with just power, they wanted to better suspension systems to beat their European counterparts.

This meant doing away with the X Frame, and creating new crossmembers, coil over tubular shocks for the front end, and the first independent rear suspension for the Corvette. Decreasing the wheel base for the car, and stiffening the frame with the cross-members and allowing the tubular shocks to handling dampening, the new Corvette was not only cheaper to mass produce, but also had better maneuvering ability and weighed less.

Now not only did the Sting Ray handle better, but the engines introduced in 1962 offered horsepower options that ranged from 250 HP to a whopping 360 HP Fuel Injected Option (Known as the L84, of which 2,610 were made for an additional \$430). As any racer knows, anything that moves that fast needs to brake fast as well, and in the '63 Sting Ray the brakes were modified by increasing the width of the 11" brake drums (4 wheel disk brakes were introduced in 1965).

What is probably the most immediately noticeable sign of the 1963 model was the Coupe's Split Rear Window. Although there is no definitive reason for this, some feel that Chevrolet was having difficulty creating a rear glass panel for the newly designed curves of the Sting Ray. It was several criticized by some experts for being difficult to see out of the back, although enthusiasts loved it, along with the first "hidden" headlights.

**Presentation of Charity Checks:** President Paul Hertel presented checks for \$1,000 each to two of our 2001 charity selections. Emil Franks was present to accept the check for the National Alliance for the Mentally III in memory of Mike Flowers.

**President:** Paul Hertel opened the meeting with a reminder that members and guests should only park on the rooftop in unmarked spaces for the meetings. Everyone introduced themselves and most prospective members said that they found us through our web site.

**Treasurer Report:** Barbara Shaw presented the Treasurer's report for the month of September 2002.

**Concours:** Don Kerndt reported that he and Collin will be gearing up for the 2003 Concours which is planned for May 18. Paul spoke with Dennis Caster prior to this meeting and he said he wants to get involved in the planning process as early as possible.

**Historian:** Jeff Kirk had the following trivia questions for the members:

Q. What 3 options were available on the 1953 Corvette?A. Heating, AM Radio, Convertible.

- Q. What was the first year power seats were available on both the passenger and driver seat?
- A. 1987. In 1981, the power driver seat was an option, but it wasn't until 1987 that both the passenger and driver had it.
- Q. Four tail lights is a trademark of the Corvette that started in what year?
- A. 1961.

# JUSTIN BELL DRIVING SCHOOL AT VIR

October 28 was the start of a three-day driving school put on by the Justin Bell Motorsports Experience at Virginia International Raceway. To have the opportunity to attend a driving school was something that I had wanted to do for quite awhile. The chance to drive someone else1s cars, Z06's and SS Camaros, made it even better.

To begin the school off right, I attended the VIR Speed Fest the weekend before the school. The weekend was filled with practice, qualifying, and racing for Spec Racers, F2000, Spec Miata, World Challenge Touring Cars and GT's, and Trans Am. There was a lot of exciting racing, and VIR has a number of good areas to watch the action. Corvettes were the featured margue, which corresponded to a good parking spot at the track, and free parade laps during a break in the action on Saturday. A Mustang won the last Trans Am race at VIR in 1966. A Mustang (kind ofS) also won the race on Sunday when Boris Said switched from his Saleen to a Mustang. Justin Bell was competing in the Trans Am race with his Vette. He started in 5th place due to slow qualifying times. He was able to move up to 4th place by the last lap. He then made a very interesting pass at the end of the back straight as they approached a steep downhill section of the tracked named the roller coaster. Bell took an inside line that forced the car he was passing wide in the tight right turn. His pass was successful, and he ended up on the podium with a third place finish. He later made the comment that anyone attending his driving school should not try to duplicate his actions.

VIR was built in the 50's but was not used from the late 60's until 1999. The main track is over three miles long with 16 turns, winding though the rolling Virginia hills. Since reopening, the track has been repaved, and improvements have been made throughout the course. A number of new buildings have been added or are in the planning stages. There are plans for luxury spectator boxes on the back straight, condos/time shares, and new trackplex buildings. Apparently over \$28 million has already been spent on the track.

The weather for the races on Sunday was beautiful. By the time the school started on Monday, the rains had arrived. There were about 30 people taking the class, including Mike Sarver, another NVCC member. The students were separated into three groups. These groups would be assigned to different activities during each teaching session. The first classroom session was short and we were off to the track.

We used only part of the VIR track on the first day. There are additional track sections that split the full track into North and a South courses. We first learned the North course. One group worked on half the turns, while the second group worked on the other half of the turns. This was a low speed event with no helmets. One instructor had two students. The instructor was in a lead car with a student driver. The follow car had a student driver. This teaching method was used during the three days of classes. The turn in and apex points of the turns were marked with cones, and the instructor would point out the correct line. The instructor would then switch cars to work with the other student.

My first run was in a Camaro on a very wet track. The section of the track included the steep down hill portion of the track called the roller coaster, where Justin Bell had made his pass the day before. This series of turns has some significant elevation changes (dropping down quickly) and is well named. All I could think of was how big the Camaro felt, and that I did not want to put the car off the track on my first day. The session proceeded without incident, and then we switched to the other part of the North track. This time we were in the Corvettes and it felt much better.

While two of the student groups were on the course, the third group was on the skid pad. A slalom course was set up with cones, and we learned about car control in the wet. We took turns driving the one car assigned to our group while the rest of the group huddled under a tent trying to stay dry.

The afternoon session included laps on the full North course, using helmets and five-point harnesses. We received a good amount of track time. Speeds were lower due to the wet conditions but the cars still went pretty quickly. We switched between Corvettes and Camaros, with an instructor in the lead car. Another group did a braking drill. The object was to stop the car from 60 mph without having the ABS kick in. The next drill had us stopping using the ABS.

The next day was still wet. During the morning session, the instructors concentrated on heel & toe practice, and we received some additional time on the North track. The afternoon had us learning the South track. There was a real interesting turn at the end of the back straight. It was a late apex, tight, downhill turn that made the track seem to get very narrow, very quickly. There are significant elevation changes on this track, which placed a premium on the correct positioning of the car. The North track joins the main track for a series of quick turns that end at a hairpin turn, named the Oak Tree. On one lap, I noticed that an instructor had spun a Vette coming out of this turn. He later said something about the active handling not engaging, but maybe it was just too much second gear gas on the wet track. When our group was not in the cars, we were back at the skip pad driving a figure eight course. The idea was to control the car as the rear end slid out, and run three laps as quickly as possible. A couple of the students ended up working on 360-degree skids when they got on the gas too early.

At the end of the 2nd day, there was a banquet for the students and instructors. It was held at VIR1s plantation clubhouse, located on the race track grounds. The clubhouse had the feeling of an old mansion but included a poolroom, bar, and dining areas. We had an opportunity to talk with some of the other students and instructors. Mike and I were pitching the NVCC to anyone from the Northern Virginia area. I even approached Carl Hunt, from Manassas, only to find out that he was already a member, oops! The dinner conversation seemed to concentrate on cars and racing, which was no surprise.

Wednesday was finally clear and the track was dry. The morning was spent in practice start drills on the full track. The students were in the Camaros and the instructors in the Corvettes. The first lap was used to line up the cars for the rolling start. Once we got the green flag, we went like hell down the straight until reaching a cut off point before the first turn. We let off the gas before the turn, and then proceeded around the balance of the track. It was quite an experience to have cars all around you when the flag dropped, especially with the instructors in the Corvettes positioned in the back of the field. You could have six Vettes pass you in an instant as you tried to get the Camaro up to speed. Being able to drive the full track, in dry conditions, was great but the focus was on doing the practice starts. It would have been nice to use some of the time for more practice runs on the course.

The afternoon had us back on the full track in the lead/follow car set up. The Corvettes and Camaros were on the track at the same time. The starter released the cars at intervals to provide spacing around the track. There were no speed limits enforced as long as the car was being driven safely. Passing was allowed on the straight, if you received the pass signal from the car in front of you. I was able to get in a fair amount of laps on basically a clear track. The biggest hassle was trying to switch from one car to another and get the 5-point harness adjusted quickly.

One neat thing that the school had was special telemetry equipment on the Corvettes. There were digital cameras facing forward, rear, on the driver, and on the pedals. The video, sound, speed, tach and G forces were recorded on a memory chip. After your run, the chip would be pulled from the car and written to a CD. Special software contained on the CD showed the telemetry data and the various camera images for your run. Also included was a diagram of the track, with a position locator that corresponded to the video images. Analysis graphs were also available with the software. The first CD was free with an additional fee for CD's of other runs. Even with some equipment problems at times, the concept was impressive and a nice keepsake from the school.

While two groups were on the track, the third got a two-lap ride with Justin Bell. It was a wild ride and brought you down to earth quickly if you thought you were hot stuff on the track. During my run, Justin Bell decided to time his run on the Corvette's DIC. As we approached the back straight (about the halfway point), he mentioned that, based on the elapse time, he would have already completed the lap in his Trans Am car. During the run, telemetry equipment was operating, and I got a CD of my laps with Bell. It was fun to watch him at work.

Too soon the track time was over as was our time at the school. It had been a lot of fun, in spite of the rain. The instructors were good, and Justin Bell was involved and available during the three days. Driving a Z06 was a blast, and VIR is a great track. This was the first time the school had been run at VIR and there were some organizational issues that I expect would not have happened at their base track in Florida. The Justin Bell Experience lived up to its billing.

I understand they will be back at VIR next year in June with 1 day, 2 day, and 3 day classes.

I'd like to thank all of the folks who came out and ran with us this year. I would especially like to recognize those who came out and supported us by working areas such as setup, timing, corners, etc. We could not have done it without your help.

One of our biggest challenges from the beginning has been posting results quickly and accurately. Not long ago we did not have our digital display panel showing the driver his time upon crossing the finish line. We had people feverishly writing down times and others literally running these little slips of paper across the track to others who tried to find the corresponding driver's name on the results board. There were delays and there were mistakes. Drivers were not happy and it was hectic for the workers. This year's event marked the end of our long search for the answer - networked laptops and a better-organized posting board!

We've had problems in the past with the reliability and "user friendliness" of the timing hardware and software. Every failure in timing necessitates at least one re-run and these additional runs cost time and sometimes cause driver frustration. This year we used our latest hardware and software acquisitions and they were exponentially more reliable and much easier to use. Without these improvements the rain would have wiped us out. There would not have been enough time to get in all the events if we had been plagued with the need for re-runs like we have been in previous years.


